Bids in sealed envelopes must be addressed and submitted to the Ministry of Defence's Procurement office before 10:00 Hrs local time on **5. October 2022**. Late bids shall be rejected and returned unopened.

4. The opening of bids will take place on the same date of submission of bids in the presence of bidders or their representatives who choose to attend from 10:30 Hrs local time in the conference room of the MoD's Procurement office respectively as tenders are ranked.

5. Any information regarding the aforementioned tenders may be obtained by any interested bidder through a letter addressed to the MoD Procurement Office at the address mentioned above not later than 14 days before the deadline of bids submission.
